Article 1 – Identity of the Seller

Article 2 – Applicability

- 1. These Terms & Conditions ("Terms") apply to every offer, agreement, and sale concluded between Bonvin and a consumer.
- 2. By placing an order through Bonvin's webshop, the consumer agrees to these Terms.
- 3. These Terms form an integral part of all agreements between Bonvin and the consumer.



Article 3 – Nature of Goods

- 1. Bonvin specialises in the sale of pre-owned and vintage luxury items, including, but not limited to, bags, watches, and jewellery.
- 2. Bonvin guarantees that all items offered for sale are authentic. Due to the vintage and pre-owned nature of the goods, minor signs of use and wear may be present.

Article 4 – Orders and Agreement Formation

- 1. A consumer's order constitutes an offer to purchase goods.
- 2. An agreement is only formed once Bonvin confirms the order by **email confirmation**.
- 3. Bonvin reserves the right to refuse or cancel orders at its sole discretion, for example in cases of suspected fraud, stock errors, or pricing mistakes.

Article 5 – Prices and VAT

- 1. All prices are stated in euros and include VAT applicable in the consumer's country of residence, in accordance with EU VAT rules.
- 2. Where applicable, Bonvin applies the **margin scheme** for pre-owned goods in accordance with EU VAT law. In such cases, VAT is included in the sales price but cannot be separately itemised or deducted.
- 3. For orders shipped **outside the European Union**, no VAT will be charged. The buyer is responsible for any **import duties**, **taxes**, **or customs fees** applicable in the destination country.
- 4. Prices are subject to change. The price applicable at the time of order confirmation shall prevail.

Article 6 – Payment

- 1. Payment must be made in full at the time of ordering.
- 2. Payments are processed securely through **Stripe**, Bonvin's payment service provider.
- 3. The **available payment methods depend on the country of the consumer** and are displayed automatically during checkout.
- 4. Bonvin retains ownership of the goods until payment has been received in full.



Article 7 – Delivery

- 1. Shipping and delivery are subject to the terms set out in Bonvin's **Shipping & Delivery Policy**, which forms part of these Terms by reference.
- 2. By placing an order, the consumer acknowledges and accepts the provisions of the Shipping & Delivery Policy.

Article 8 – Returns and Refunds

- 1. Returns and refunds are subject to the terms set out in Bonvin's **Return & Refund Policy**, which forms part of these Terms by reference.
- 2. By placing an order, the consumer acknowledges and accepts the provisions of the Return & Refund Policy.

Article 9 – Warranty

- 1. For consumers residing in the European Union, Bonvin complies with the statutory consumer warranty rights under Dutch and EU law. For pre-owned and vintage goods, this warranty period is limited to **1 year** from the date of delivery.
- 2. During this period, the consumer may claim warranty if the product does not conform to the agreement due to a defect that already existed at the time of delivery and was not clearly stated.
- 3. The warranty does not cover:
- Normal wear and tear or age-related signs of use typical for vintage goods,
- Defects that were clearly described or shown in the product description/photos at the time of purchase,
- Damage caused by misuse, accidents, or unauthorized repairs or alterations.
- 4. In the event of a valid warranty claim, Bonvin will first attempt to repair or replace the item. If this is not possible, the consumer is entitled to a refund or price reduction.
- 5. Bonvin does not provide any additional commercial warranty beyond the statutory rights described above.



Article 10 – Authenticity & Brand Disclaimer

- 1. Bonvin guarantees that all products offered for sale are authentic.
- 2. Our authentication process is solely based on our experience. No data has been provided or used from any of the brands listed on our website and only the brands can 100% guarantee authenticity. Please note that the brands listed on our website are neither responsible for nor bound by any of our authenticity findings.
- 3. Bonvin is not affiliated, associated, authorized, endorsed by, or in any way officially connected with the brands offered or any other trademarks mentioned.
- 4. All brand names and trademarks remain the property of their respective owners. They are used solely to describe the goods and are not intended to suggest any affiliation with Bonvin.

Article 11 – Intellectual Property

- 3. Bonvin is not liable for delays caused by third parties, courier services, customs authorities, or events of force majeure.
